

# Release Form, Waiver of Liability / 1 form per rider (entrant)

## THIS WAIVER IS A CONTRACT WITH LEGAL CONSEQUENCES, READ IT CAREFULLY BEFORE SIGNING.

In consideration of the acceptance of my entry in the Dehydrator, I hereby acknowledge that I am assuming risks and agree to indemnify, not to sue and release from liability the Dehydrator, its employees, volunteers, members, board, sponsors, promoters, independent contractors and affiliates (collectively releases) and that I am giving up substantial legal rights.

I fully realize the dangers of participating in a bicycle event and fully assume the risks associated with such participation including, by way of example, and not limitation, the following: the dangers of collision with pedestrians, vehicles, other riders, and fixed or moving objects; the dangers arising from surface hazards, equipment failure, inadequate safety equipment, weather conditions, and the releasee's own negligence, the negligence of others' and the possibility of serious physical and/or mental trauma or injury associated with athletic cycling events.

I hereby waive, release and discharge for myself, my heirs, executors, administrators, legal representatives, assigns, and successors in interest (hereinafter collectively "successors") any and all rights and claims which I have or which may hereafter accrue to me against the Dehydrator, the Duncan Band Boosters, Duncan Public Schools, all volunteers, members, board, sponsors, the organizers, Independent contractors, affiliates and any promoting organization(s), Medical providers, property owners, law enforcement agencies, all public entities, special districts, and properties (and their respective agents, officials, and employees) through or by which the events will be held for any and all damages which may be sustained by me directly or indirectly in connection with, or arising out of, my participation in or association with the event, or travel to or return from the event.

I understand that still and video images of me may be taken in conjunction with the Dehydrator and agree that they may be used to promote the Dehydrator and sponsors or for medical purposes.

Riders who are treated by medical volunteers shall have no expectation of privacy when medical care is done in an open-air tent. In addition, they shall have no expectation of consent to publish case reports and/or aggregate data in professional literature, and they consent to treatment.

I agree that it is my sole responsibility to be familiar with the ride course, and special rules for the event. I understand and agree that situations may arise during the ride which may be beyond the immediate control of the ride officials or organizers, and I must continually ride so as to not endanger neither others nor myself. I accept responsibility for the condition and adequacy of my equipment I will wear a helmet certified by ANSI SNELL<CPSC or DOT performance tests and that can protect me against serious head injury, and assume all responsibility and liability for the selection of such a helmet. I have no physical or medical condition which would endanger others or myself if I participate in this event, or would interfere with my ability to participate in this event.

I agree, for myself and successors, that the above representations are contractually binding, and are not mere recitals, and that should I or my successors, assert a claim in contravention of this agreement, I or my successors shall be liable for the expenses (including legal fees) incurred by the releasees in defending the claims. This agreement may not be modified orally, and a waiver or modification of any provision shall not be construed as a modification of any other provision herein or as consent to any subsequent waiver or modification. I consent to the release by any third party to release and insurance carriers of my name and medical information that relate solely to any injury or death I may suffer arising from this event. Every term and provision of this contract is intended servable. If any one or more of them is found to be unenforceable or invalid that shall not affect the other terms and provisions which shall remain binding and enforceable. . ***NO Riders under the age of 14 will be allowed to ride without an adult.***

# THE DEHYDRATOR 2025 Duncan, OK

## Registration Form:

**WHEN AND WHERE:** Saturday, July 26, 2025, rain or shine, at the Simmons Center, 800 Chisholm Trail Parkway, Duncan. Turn west at U.S. Hwy. 81 and Beech, then turn north on Chisholm Trail Parkway for ½ mile. Riders will be staged in the Center's north parking lot. The riders will start on their respective courses at 7:00 a.m.

**ENTRY FEE:** \$45 per person, \$60 per tandem-bike team, non-refundable. Free event T-Shirt. \$50 per person and \$65 per tandem-bike after July 11, 2025.

**SIMMONS CENTER:** Use your ride number or wrist band to receive a free meal and enjoy the Center's shower facilities on the day of the event. **Extra meals are available for a small fee**, and use of the pool and sauna are an additional \$5 payable to the Simmons Center. **Alcoholic beverages are NOT allowed anywhere on the premises.**

**LATE ENTRY FEE:** Entries should be postmarked by Monday, July 7th; 10 pm, and online registration closes 10PM Friday, July 11th. A \$5.00 late fee will be assessed on all subsequent entries.

**PACKET PICK-UP:** Packets can be picked up at the Simmons Center Friday, July 25 from 6-9 p.m. and beginning at 5:30 a.m. the morning of the ride.

**REST STOPS:** Stops will be provided approximately every 10 miles on the routes. There will be plenty of fluids, fruit and cookies.

**HEALTH AND SAFETY RULES:** Helmets will be required for all entrants. Please follow all traffic laws throughout the ride for your own safety. Sag wagons will be available with water and road assistance for riders who have mechanical trouble or become too fatigued to finish. ***NO Riders under the age of 14 will be allowed to ride without an adult.***
